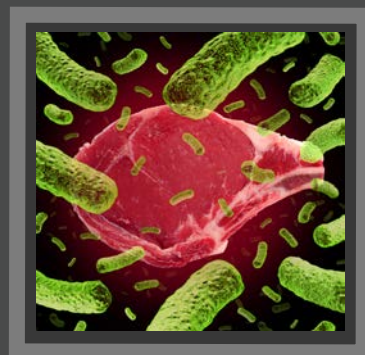
An **Infected Person** (as diagnosed by a physician) has visited your **Covered Location** (restaurant) while carrying the pathogen;

The establishment has been shut down by a **Public Health Authority**, whether individually or as part of an area wide multi-business shut-down.

This Pandemic Endorsement includes business interruption coverage and incident response expenses such as cleaning and mitigating and crisis management services.

The **TNR® Program**, developed in 1999 is an essential component of an insurance plan for the hospitality industry. Most standard PC/CGL policies do not trigger for food borne illnesses or pandemic perils since they do not actually consider an illness as "physical damage".
